#### Case study

#### We saved the Commonwealth Games

#### Issue:


Stagecoach provided all the transport provision for athletes, officials, spectators and the police for the Commonwealth Games in July/August 2022 and took a lease on a former truck depot near Birmingham in order to facilitate that. Stagecoach were in the process of preparing the site in readiness for the games when a large encampment of travellers forced entry onto the site and refused to move out, jeopardising the entire event.. The client needed vacant possession within days in order to keep on schedule with preparatory works.

#### Approach:

We burned the midnight oil to prepare and issue possession proceedings at the Royal Courts of Justice and to persuade a Master to shorten the time frame for service.

#### **Result:**

The Court papers were served on the travellers the same day and the case was listed for hearing the next working day. The Court made an order for immediate possession and we were able to arrange for High Court Enforcement Officers to take back possession.

#### Case study

#### Transactional issues / misrepresentation

How Hägen Wolf helped a buy-to-let investor to return a mis-sold holiday flat and to recover damages.

#### Issue:

Our client had purchased a holiday flat in Whitby as a buyto-let investment. The flat shared a building with a live music venue. The seller lied in pre-contract enquiries about noise nuisance complaints. Our client only discovered the problem when holiday-makers started complaining about noise and vibration waking them up at night. He later discovered that noise abatement notices had been served prior to him purchasing the flat and that there was no sound-proofing in the building. Having discovered the truth, the flat was unsellable and unlettable and, in real terms, worthless. The seller (who also managed the building) washed his hands of this, moved to the far east and the client's previous solicitors were getting nowhere.

#### Approach:

We assembled compelling evidence, issued court proceedings and were able to negotiate a settlement.

#### **Result:**

The seller bought the flat back off our client for the original purchase price, paid substantial damages and legal costs.
